The PTR has the right to refuse entry to anyone for any reason it deems necessary, including but not limited to classification issues. Questions or concerns should be directed to the PTR.

Each participant is fully aware, completely understands, and accepts that participation in the Event, whether as a contestant, employee, volunteer, exhibitor, sponsor, or spectator, is dangerous and that the events and activities associated with, relating to, arising out of, and concerning this participation present substantial, serious, and real risks of personal injury or death to the participant, and the loss of, damage to, or destruction of the participant's personal property.
